Summer Tax Time

Enclosed is the Summer Tax Bill. **The last day to pay without interest is Sept. 14 (open 9 am-5 pm).**

Last day to file for deferment is Sept. 14
(waives interest through Feb 14, 2022).

Easy payment options: mail, drop box at the hall, or online via link at www.piersontwp.org (convenience fee noted). Payments also accepted at the **Treasurer's Office**; or **Independent Bank in Howard City or Sand Lake** (you must bring the bill with you). Checks/money orders made payable to Pierson Township.

If you pay your taxes via **mortgage escrow** and you have either recently refinanced, paid off your existing mortgage loan or you have financed a new home,



please call or email the Treasurer's office to verify the mortgage lender & mailing address for billing purposes.

Understanding your Tax Bill

Each year in February, property owners receive a "Notice of Assessment", which states the new Assessed and Taxable values for the year.

Assessed Value: This value is half of the fair market value of your property. This value changes each year based on the expected sale price of your property as determined by studies of actual sales in neighborhoods, taking into consideration the description of your property (land value, building age and size, etc.), sales studies from Montcalm County, and State of Michigan guidelines.

Taxable Value: This value is used to calculate your tax bill.

Principle Residence Exemption (PRE): Is a tax break on the school millage (up to 18 mills) for a home that is a primary residence. Rental properties and vacation homes do not qualify for this tax break. The PRE must be filed by June 1 to have the adjustment made for the current tax bill. For special situations, please contact the Assessor for more information.

After some comparison of services, pricing and the benefit of a reporter to cover area news, the Township Board at the June 15, 2021 meeting decided to switch publications to the Greenville Daily News. Wind Ordinance

There has been much talk about "Wind" in Montcalm County. Pierson Township is a Zoned Community. What that means is that the township can regulate building and land uses.

The Wind Ordinance has been in the hands of the Planning Commission since 2020. After holding the required public hearings the Wind Ordinance became effective November 17, 2020 when the Board accepted the proposed document. There have since been two amendments, February 2021 to add a Wind Zone and June 2021 amendment to a set-back from 2X to 4X on page 8 (* no change to page 11 at 4X).

The main components of what will determine **where or if** a commercial wind tower can be placed is by decibel limits and set-backs from roads, dwellings and non-participating property lines. The Wind Ordinance 2020-01 as amended can be found at www.piersontwp.org.
